CIRCULAR

As a post- earthquake strategy for reconstruction and rebuilding of infrastructure projects in Sikkim under Prime Minister's Package to Sikkim, the Rural Management and Development Department has undertaken reconstruction of 7,972 fully/severely damaged rural houses under the "Reconstruction of Earthquake Damaged Rural Houses" (REDRH) project.
