Subject: Update on new modules made functional in the web based MIS of the REDRH Project

Sir,

As you are aware, the web-based MIS www.sikkimrmdd.gov.in has been made operational with inhouse support received from the Department of IT, Government of Sikkim. After completing the beneficiary module and the e-stores, two new modules have been recently completed and made available which are as follows:

Physical progress module: This module to be updated from the District level provides the option to update the physical progress of house construction - beneficiary wise (in the five stages – beneficiary identified, plinth complete, roof complete, house fully complete, house handed over to beneficiary) in a user friendly manner. The existing user ids and passwords used for uploading the beneficiary details (from the district level) have also been authorized for updating this physical progress module. The physical progress so entered beneficiary wise will be reflected in the home page in an aggregated manner. Training for the Deputy Secretary of North and West Districts has also been organized. East and South Districts may like to get in touch with Mr. Prem Rai Assistant Director IT <9593371156> for capacity building regarding this module. This physical progress module needs to be updated on a weekly basis from the District level (screen shot enclosed). This module will supplement (and note replace) the hard copy MPRs to be sent by the Districts.

Documents / **Circulars module:** This module provides the list of all the circulars/letters/guidelines/training material which has been provided from RMDD headoffice till date. All the documents are available in signed pdf format in chronological order for ready reference and use. This module will be kept updated in future as well (screen shot enclosed).
